5. Bidder shall submit the sealed quotation on or before 12:00 hours on 2076/01/23(6th May, 2019) at the office of Ministry Of Land Management, Agriculture and Cooperative Province no 5, Butwal. All bids must be accompanied by the voucher specifying deposit of mentioned amount of bid security into the following account, valid 45 days beyond Bid validity.
6. Bids must be valid for a period of 45 days after the bid closing deadline. Bids must be accompanied by a Bid Security in the amount as mentioned in the above table either in the form of Bank Voucher in the name of Pradesh Lekha Niyantrak, Karyalaya, Butwal, Dharauti Khata No. 3120502000000 (Rastriya Banijya Bank, Butwal) or irrevocable and unconditional Bank Guarantee issued by "A" class commercial bank with a minimum amount as indicated in the above table.
